## **Notice**

Sub: Declaration of final results of Combined Administrative Services Examination (CSIR CASE -2023)— reg.

CSIR issued Advt. No. E-I/RC/2023/1 for filling up 444 administrative posts. The vacancy comprised 76 vacant posts of Section Officer in Pay Level-8 (Group B Gazetted) and 368 posts of Assistant Section Officer in Pay Level-7 (Group B Non-Gazetted). The Examination process was termed as CSIR- Combined Administrative Services Examination – 2023 (CSIR CASE-2023).

- 2. The Online Application Portal remained open from 08.12.2023 to 13.01.2024 for accepting online application from the candidates. 475688 applications were received against the advertisement. The advertisement contained Scheme of Examination, Syllabus and Break up of Marks. The scheme of Examination consisted of Stage-I Examination (Paper-I and Paper-II), Stage-II Examination (Paper-III and CPT for ASO post only) and Interview for the post of Section Officer only.
- 3. The Stage-I Examination was conducted from 05.02.2024 to 20.02.2024 in 19 cities. Paper-I and Paper-II were held in the morning session and afternoon session respectively. The result of Stage-I Examination containing Minimum Threshold and Cut-off Marks and list of provisionally shortlisted candidates for Stage-II Examination were notified vide CSIR Web Notice no. 3-2(a)/2023-E. I (RC) dated: 03.06.2024
- 4. The Stage-II Examination consisting of Paper-III and CPT (CPT for the post of ASO only) was held on 07.07.2024 in the morning session and afternoon session respectively, as per CSIR Web Notice of even no. dated 21.06.2024. The CPT Re-test was conducted on 01.09.2024 and 02.09.2024 as per CSIR Web Notice of even nos. dated 02.08.2024 and 24.08.2024.
- 5. The Minimum threshold marks of Paper-III was notified vide CSIR Web Notice of even no. dated 28.06.2024. The threshold marks for CPT was notified vide CSIR Web Notice of even no. dated 01.11.2024.
- 6. The Interview, for the post of Section Officer, carrying 100 marks, was conducted during 25.10.2024 to 29.10.2024 as per CSIR Web Notice of even no. dated 02.10.2024. The Document Verification of the candidates, who attended the interview, was carried out during this interview process. The Document Verification process for the post of Assistant Section Officer was conducted from 18.12.2024 to 24.12.2024 as per CSIR Web Notice of even no. dated 05.12.2024.
- 7. As per Scheme of Examination contained in the Advertisement, Final Select List for the post of **Section Officer** is to be prepared keeping in view the number of vacancies and total marks obtained by the candidates out of 600 (Paper-I, Paper-II, Paper-III and Interview), subject to securing the minimum threshold / cut-off marks

wherever prescribed/ required and notified by CSIR. Further, final Select List for the post of **Assistant Section Officer** is to be prepared keeping in view the number of vacancies and total marks obtained out of 500 (Paper-I, Paper-II and Paper-III) by the candidates, subject to securing the minimum threshold/ cut-off marks wherever prescribed/required and notified by CSIR and qualifying marks in CPT.

8. In view of the above, the lists of candidates empanelled in Select List, in order of merit, for the post of Section Officer and Assistant Section Officer are enclosed herewith as **Annexure-A** and **Annexure-B** respectively. The category wise cut-off marks for empanelment is given below: -

- 10. The empanelment of the candidate in the Select List is purely provisional, subject to fulfilment of all the conditions stipulated in the advertisement. In case it is found at any stage that the candidate does not fulfil the eligibility criteria or any information provided by the candidate is found to be false or is not in conformity with the eligibility criteria mentioned in the advertisement or found ineligible on other grounds, the candidature of such a candidate will be rejected at any stage, even after appointment.

- 12. The empanelment of the candidates in the Select List is subject to the outcome of various court cases pending before the Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi in various OAs related to CASE-2023.
